## I. CALL TO ORDER

## **III. APPROVAL OF JUNE 14, 2023 MEETING MINUTES**

# IV. ELIGIBLE TRAINING PROVIDER LIST (ETPL)

Schools may not be required to be brought before our Board of Directors for approval and the Career Services Committee may not be involved as they were before. Mary Anne explained that she had not received the official change yet and was informed to continue to conduct business as usual until informed otherwise.

Keitha Daniels asked for a motion to make a recommendation to the Board of Directors to approve adding Gulfside Medical Training Institute to the Eligible Training Providers List.

Board of Directors to add Gulfside Medical Training Institute to the Eligible Training Provider List, Jennifer Thayer seconded. Members approved, none opposed.

Barbara Short also reviewed the findings, observations, recommendations, and corrective measures from the Taylor Hall Miller Parker (THMP), PA Monitoring Report. THMP provides internal fiscal and programmatic monitoring services for us.

Peg Elmore, President and CEO for CareerSource Southwest Florida gave a praise report, informing the committee that Region 24 CareerSource Southwest Florida has gone from a B+ to an A+ in the Florida Commerce letter grade report over the last 2022-2023 year.

Mary Anne Zurn explained we will be going out for bid for One-Stop Operator in December 2023 and would like the Career Services Committee members to serve as the review panel. Keitha Daniels believes it would be a very good idea for the committee to be the review panel for the request of proposals for the One-Stop Operator.
