CALL TO ORDER

The meeting was called to order by Chair, Mike Biskie at 3:00 p.m. Lyntoria Thomas, Administrative Services Assistant, called role and confirmed quorum was met.

II. PUBLIC COMMENT- None

III. APPROVAL OF NOVEMBER 13 AND NOVEMBER 22, 2024 MEETING MINUTES

Mike Wukitsch made a motion to approve the November 13 and November 22, 2024 meeting minutes; Drummond Camel seconded; the motion was unanimously approved.

IV. 2024 FINAL AUDIT REPORT

Mike Egan, CareerSource Southwest Florida Chief Financial Officer, gave an overview of the 2024 Final Audit Report prepared by certified public accounts Grau & Associates. Mike explained the report was a clean audit with no findings. The staff is

happy with Grau's services and has exercised our right to extend the contract another year.

Board of Directors Chair, Mike Biskie expressed his appreciation to Mike Egan and his team. Mike Biskie shared Mike Egan is ranked as one of the top Chief Financial Officers in the State of Florida and throughout the Workforce Development sector.

V. FACILITIES

Labelle Lease- Greg Urbanic, Board Attorney gave an overview of the lease that will commence July 1, 2025. Mike Egan explained the current location is not easily accessible and in need of repairs. Mike stated the new location is well traveled, easily accessible, and the landlord has started the process of pulling permits to begin renovations. Mike asked the Board of Directors to give Peg Elmore, President CEO of CareerSource Southwest Florida, permission to sign the Labelle lease.

Adrian Llanes made a motion to have Peg Elmore sign the Labelle lease; Brent Kettler seconded; the motion was unanimously approved.

Clewiston Update- Mike Egan reported we have not received a response from the landlord on the original lease proposal. Mike explained they have developed Plan B and have found another location. CareerSource Southwest Florida attorneys and the attorneys for the new location are in touch with each other and have agreed to draw up a preliminary lease agreement to present to the Executive Committee.

Immokalee Update- Greg Urbanic reported thus far, the results are positive. The buyers are doing their due diligence, the right of first refusal has been delivered to Collier County Public Schools, and the agenda for the next Collier County Public School Board meeting should be posted prior to our March meeting so new information may be available. The two Collier County Public Schools attorneys and Greg are meeting on Friday January 10, 2024.

VI. STRATEGIC PLAN UPDATE

Mike Biskie explained the staff have been diligently working on obtaining necessary data and bringing it before committees in order to finalize the goals before the start of the 2025-2026 program year. Mike would like the staff to keep moving forward with the strategic plan and have a more defined plan at the one-year mark in May.

VII. REGIONAL PLANNING DESIGNATION

Peg Elmore, President CEO for CareerSource Southwest Florida gave an overview of the REACH ACT that requires CareerSource Southwest Florida to enter into a regional planning agreement with an adjoining workforce region. The Board previously approved establishing a regional plan with the Heartland Region which consists of Desoto, Hardee, Highlands and Okeechobee counties. Peg explained the regional planning designation request includes required labor market information that must be signed and approved by each of the Chief Local Elected Officials in our region and submitted to the CareerSource Florida Board.

Mike Wukitsch made a motion to approve the regional planning agreement with Heartland as the adjoining workforce region; Phil Magin seconded; the motion was unanimously approved.

VIII. SUCCESSION PLAN

Mike Biskie explained that Peg Elmore presented the Executive Committee with a draft succession plan at their December 2024 meeting. Mike explained the plan highlights key leadership positions within the organization, it provides different strategies based on short and long-term absences as well as vacancies. The succession plan highlights what happens if an acting President/CEO must be named, who would be the first position in line and who would be the second position in line. The plan also identifies steps to take in naming and hiring a permanent President/CEO.

Peg Elmore gave an overview of the plan and the changes that were made. The Board of Directors were able to read through the succession plan, ask questions, and provide feedback. After reading and discussing the board members expressed how well written and detailed the succession plan is and that the plan is a living document.

Keitha Daniels made a motion to approve the succession plan as written; Bill Diamond seconded; the motion was unanimously approved.

What is NCPEP?

The Non-Custodial Parent Employment Program (NCPEP) assists unemployed or underemployed non-custodial parents in making regular child support payments through obtaining and maintaining employment.



- NCPEP program was established in 2022 in FL.
- . Similar in other states since 2005.
- . Florida Commerce was awarded **\$7.05** million for 2024/2025.
- . Currently 10 program operators in FL.
- October 2024 Notice of Funds Available (NFA) arrived for \$1,040,971.

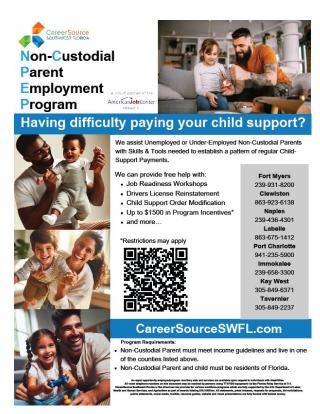
